- Registered Office: The registered office of the Society shall be at # 1941, 2. Phase-10, Mohali for the present and any other place in the Indian Union as may be determined by the Governing Body.

The objects of the Society are:

- To use all the income from the students by way of fees, boarding and lodging and from other institutions and form property movable or immovable or from the works of the society or from staff of the schools or the institutions or from the rent from the building wherever derived for the pursuit of the objects of the society as set fourth in memorandum provided that no portion thereof be distributed among its members by way of profits or dividend or bonus except where payment or usage is allowed to employees, members, office bearer or any other person in lieu of services rendered or agreed to be the society/ institution set by the Society.
- To collect donations, membership fee and other contributions from the 0) members and others.
- To frame by laws, rules and regulations for the smooth working of the p) institutions and to alter or amend or re-substitute new rules and regulations as the society may deem fit.
