

**MEMORANDUM OF ASSOCIATION
OF
CHANDIGARH EDUCATIONAL SOCIETY**

1. **Name:** The name of the Society is "Chandigarh Educational Society".
2. **Registered Office:** The registered office of the Society shall be at # 1941, Phase-10, Mohali for the present and any other place in the Indian Union as may be determined by the Governing Body.
3. **The objects of the Society are:**
 - a) To establish, promote or to render aid to school(s), college(s), educational institutions, technical institutions, technical institutions, training institutions in one or all fields of engineering, research, medical, management, commerce, arts or any other system of education.
 - b) To promote education, vocational, technical and otherwise the diffusion of useful knowledge medical relief, industrial training including all aspects of rural reconstruction and social welfare projects.
 - c) To engage in social welfare activities aimed at improving living conditions and general welfare of the poor and indigent persons of whatsoever occupation irrespective of race, caste, community or creed.
 - d) To promote deeper spiritual values in personal and community life.
 - e) To diffuse such useful secular, social and religious knowledge.
 - f) To print and publish any news paper, periodicals, books and to utilize other mass communication radio, film and television for spread of knowledge.
 - g) To train, to maintain the personal to be incharge of different schools and institutions of the society.
 - h) To establish building for such objects, libraries, reading rooms equipped them with the necessary supply of books, paper, periodical, furniture and audio-visual aid.
 - i) To receive gifts or money or other properties, both movable and immovable or any bequests for any one or more objects of the society.

- j) To acquire by purchase, lease, gift, grants or likewise from any person, company, trust, Govt. organizations movable or immovable properties of all descriptions deemed necessary or useful for any purpose of the Society and administer the same.
- k) To alienate by way of sale, lease, mortgage, pledge, exchange, gifts or otherwise the subscriptions, contributions, assistance, pecuniary or otherwise to charitable institutions, bodies or persons as from time to time seen necessary or appropriate.
- l) To invest, lay aside, deposit in banks or post offices otherwise deal with money or funds with Society not immediately required for the objects of the Society.
- m) To borrow or raise funds from banks and other financial institutions or private parties for the purpose and objects of the society with or without security in any manner as society may think fit and repay the same.
- n) To use all the income from the students by way of fees, boarding and lodging and from other institutions and form property movable or immovable or from the works of the society or from staff of the schools or the institutions or from the rent from the building wherever derived for the pursuit of the objects of the society as set fourth in memorandum provided that no portion thereof be distributed among its members by way of profits or dividend or bonus except where payment or usage is allowed to employees, members, office bearer or any other person in lieu of services rendered or agreed to be the society/ institution set by the Society.
- o) To collect donations, membership fee and other contributions from the members and others.
- p) To frame by laws, rules and regulations for the smooth working of the institutions and to alter or amend or re-substitute new rules and regulations as the society may deem fit.
- q) To sell, mortgage property of the society for the upliftment of the society.
